**IMPORTANT DEFINITIONS**

**PLANT**

A manufacturing facility supplying goods or services on which PCI Supplier Associate Member fees are based. Each plant with 51% or more common ownership must be included.

**GROSS DOLLAR SALES VOLUME**

The total gross dollar sales volume, all plants, of goods, services, and information furnished the precast prestressed, architectural precast concrete and glass fiber reinforced concrete industry.

**SPECIAL FEES COMPUTATIONS**

Any plant or company with common ownership of 51% or more desiring separate PCI Supplier Associate Membership may file a separate Statement of Fees as a separate company and so state that it is not included in the parent company's Statement of Fees. All rights and voting privileges are thereby accorded. Supplier Associate Members located outside the United States compute fees only on the gross dollar sales volume of sales within the United States.

**SUPPLIER'S REPRESENTATIVE**

An independent individual or company selling only PCI Supplier Associate Member goods or services. Importers and Trading Houses are not eligible for membership as Manufacturers' Representatives, but do qualify as Supplier Associate Members.

Manufacturer's Representative's Fees shall be \$2,000. annually. Annual dues must accompany this application
