

## Highlights at 2018 CIM World of Concrete auction include two concrete mixers

The Concrete Industry Management (CIM) program's signature item for its annual auction at World of Concrete in Las Vegas, Nev., is a Mack Granite Axle Back model mounted with a McNeilus 10.5 yd³ M77 concrete transit mixer, donated by Mack Trucks Inc. and McNeilus, an Oshkosh Corp. company. Kenworth and Kenworth of Central Florida have also donated a T880S bridge formula truck chassis, and Con-Tech Manufacturing has donated a Con-Tech BridgeKing 11 yd³ concrete mixer

The annual auction will be held Wednesday, January 24, 2018, in the North Hall Room N262 of the Las Vegas Convention Center. The silent auction will be held from 11 a.m. to 12:45 p.m., and the live auction begins at 1 p.m. Internet bidding will be available on the Ritchie Bros. website at www.rbauction.com. ## OSHA issues final rule setting November date for crane operator compliance

The Occupational Safety and Health Administration (OSHA) issued a final rule that sets November 10, 2018, as the date for employers in the construction industry to comply with a requirement for crane operator certification. The final rule became effective November 9, 2017.

OSHA issued a final cranes and derricks rule in August 2010. After stakeholders expressed concerns regarding the rule's certification requirements, OSHA published a separate final rule\_in September 2014, extending by three years the crane operator certification and competency requirements. This one-year extension provides additional time for OSHA to complete a rulemaking to address stakeholder concerns related to the Cranes and Derricks in Construction standard.

OSHA's Advisory Committee on Construction Safety and Health (ACCSH) recommended delaying enforcement of the certification requirement and extending the employer assessment responsibilities for the same period.
