D. Bruce Post

Donald "Bruce" Post Jr., founder of Precast Systems Inc., died May 1, 2024. He was 78. Post earned his BS and MS in civil engineering from Rutgers University. There, he participated in the Reserve Officer Training Corps, graduating as a lieutenant in the Army Corps of Engineers and serving his country at the Pentagon and in Germany.

After serving, he worked several engineering and construction firms before he established Precast Systems Inc. in 1981 in Allentown, N.J. The company constructed bridges, tunnels, parking garages, and mass transit systems across the Mid-Atlantic. In 2017, Post sold the company.

Richard Wehrli

>> Richard "Dick" Wehrli, a founder of Dukane Precast Inc., died July 27, 2024. He was 89.

In 1956, Wehrli received a business degree from North Central College in Naperville, III. Then, in 1957, Wehrli enlisted in the Army National Guard of Illinois and was commissioned as a 2nd Lieutenant in 1958, where he served until 1962.

Wehrli worked for a small ready-mixed concrete producer for three years before he and wife Judy Wehrli started Naperville Ready Mix in 1959 out of their garage. In 1964, he started a second venture, Naperville Excavating, to perform work for developers Harold and Jim Moser at the beginning of Naperville's building boom. In the early 1970s, Wehrli started another company, Easy Street Construction, one of the first contractors to use automated equipment for concrete street and curb paving. He soon became one of the most recognized experts in the field application of this technology.

In the late 1970s, Wehrli started Mustang Construction—a general contracting company—and Dukane Precast with other partners.

Wehrli served as board chair for Naperville Ready Mix, Naperville Excavating, Mustang Construction, and Dukane Precast until his death.
