## Clark Pacific commits to low-carbon concrete

This effort supports a new initiative by the White House to bolster innovative and clean construction materials. With cement accounting for nearly three-quarters of concrete’s global warming potential, this reduction marks a significant step in Clark Pacific’s ongoing journey to decarbonize the built environment.

The production of construction materials is a major contributor to global warming. Concrete manufacturing alone generates 8% of global emissions.
